The approximately 60 members of the adult orchestra started the season with a free outdoor concert of light classical music and show tunes held on a green in a city plaza in downtown Livermore on a fall Saturday afternoon. The group then performed 4 full-length classical concerts featuring guest artists and student competition winners. Concerts were held in the Bankhead theater and open to the public. They provided professional-level performances for the local community as well as the opportunity for orchestra members and competition winners to grow musically through the preparation and performance of classical music.

4b (Code:) (Expenses \$ 9,832. including grants of \$) (Revenue \$)

We sponsored a summer youth symphony for students aged 11 to 21, which gave a free public performance of the music the students had prepared.

4c (Code:) (Expenses \$ 6,165. including grants of \$) (Revenue \$)

Youth outreach activities included a free family concert in the Bankhead Theater for about 500 people on a Saturday afternoon in December. The orchestra was joined by members of a local non-profit dance studio for several dances from the Nutcracker. After the one-hour concert, an "instrument petting zoo" offered audience members an opportunity to try out instruments. A smaller group of orchestra members performed 3 youth outreach concerts in local public elementary schools, reaching approximately 1,500 students. The music director interspersed the concerts with engaging remarks about the classical music and the instruments of the orchestra.
